This appliance may be installed in an aftermarket permanently located, manufactured (mobile) home, where not prohibited by local codes. This appliance is only for use with the type of gas indicated on the rating plate. This appliance is not convertible for use with other gases.

This is an unvented gas-fired heater. It uses air (oxygen) from the room in which it is installed. Provisions for adequate combustion and ventilation air must be provided. Refer to Air for Combustion and Ventilation section on Page 7 of this manual.

A WARNING: If the information in this manual is not followed exactly, a fire or explosion may result causing property damage, personal injury or loss of life.

- Do not store or use gasoline or other flammable vapors and liquids in the vicinity of this or any other appliance.
- WHAT TO DO IF YOU SMELL GAS

Provisions for adequate combustion and ventilation air must be provided. Refer to <u>Air for</u> <u>Combustion and Ventilation</u> section on *Page 7* of this manual.

This appliance may be installed in an aftermarket,\* permanently located, manufactured (mobile) home, where not prohibited by local codes.

This appliance is only for use with the type of gas indicated on the rating plate. This appliance is not convertible for use with other gases.

\* Aftermarket: Completion of sale, not for purpose of resale, from the manufacturer

IMPORTANT: Read this owner's manual carefully and completely before trying to assemble, operate or service this appliance. Improper use of this heater can cause serious injury or death from burns, fire, explosion, electrical shock and carbon monoxide poisoning.

Any safety screen, guard, or barrier removed for servicing an appliance must be replace prior to operating the heater. The firescreen or guard designed for this unvented appliance must be installed prior to operation.

# **A** DANGER: Carbon monoxide poisoning may lead to death!

**Carbon Monoxide Poisoning:** Early signs of carbon monoxide poisoning resemble the flu, with headaches, dizziness or nausea. If you have these signs, the heater may not be working properly. **Get fresh air at once!** Have heater serviced. Some people are more affected by carbon monoxide than others. These include pregnant women, people with heart or lung disease or anemia, those under the influence of alcohol and those at high altitudes.

**Natural and Propane/LP Gas:** Natural and propane/LP gases are odorless. An odor-making agent is added to the gas. The odor helps you detect a gas leak. However, the odor added to the gas can fade. Gas may be present even though no odor exists.

Make certain you read and understand all warnings. Keep this manual for reference. It is your guide to safe and proper operation of this heater.

WARNING: Any change to this heater or its controls can be dangerous.

WARNING: Do not use a blower insert, heat exchanger insert or other accessory not approved for use with this heater.

WARNING: Do not allow fans to blow directly into the fireplace. Avoid any drafts that alter burner flame patterns. Ceiling fans can create drafts that alter burner flame patterns. Altered burner patterns can cause sooting.

Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies.

Do not place clothing or other flammable material on or near the appliance. Never place any objects on the heater.

Children and adults should be alerted to the hazard of high surface temperature and should stay away to avoid burns or clothing ignition. Heater will remain hot for a time after shutdown. Allow surface to cool before touching.

WARNING: Do not place log scraps or volcanic stone on burner.

Fireplace front and screen become very hot when running fireplace.

WARNING: Young children should be carefully supervised when they are in the same room with the appliance. When using the hand-held remote accessory, keep selector switch in the OFF position to prevent children from turning on burners with remote.

You must operate appliance with the fireplace screen and hood in place before running heater. The fireplace screen shall have openings for introduction of combustion air.

Keep the appliance area clear and free from combustible materials, gasoline and other flammable vapors and liquids.

Solid-fuels shall not be burned in a fireplace in which an unvented room heater is installed.

Installation and repair should be done by a qualified service person. The appliance should be inspected before use and at least annually by a professional service person. More frequent cleaning may be required due to excessive lint from carpeting, bedding material, etc. It is imperative that control compartments, burners, and circulating air passageways of the appliance be kept clean.

This appliance must be mounted on a fully supported base extending the full width and depth of the unit. The fireplace may be located on or near conventional construction materials. However, if installed on combustible materials, such as carpeting, vinyl tile or other combustible material other than wood flooring, the appliance shall be installed on a metal or wood panel extending the full width and depth of the appliance.

## **SAFETY** *Continued*

#### WARNING: This appliance is only for use with the type of gas indicated on the rating plate. This appliance is not convertible for use with other gases.

- Do not place propane/LP supply tank(s) inside any structure. Locate propane/LP supply tank(s) outdoors (propane/LP only).
- 3. If you smell gas
  - shut off gas supply
  - do not try to light any appliance
  - do not touch any electrical switch; do not use any phone in your building
  - immediately call your gas supplier from a neighbor's phone. Follow the gas supplier's instructions
  - if you cannot reach your gas supplier, call the fire department
- 4. This fireplace shall not be installed in a bathroom or bedroom.
- 5. Do not use this fireplace as a wood-burning fireplace. Use only the logs provided with the fireplace.
- Do not add extra logs or ornaments such as pine cones, vermiculite, or glowing embers (rockwool). Using these added items can cause sooting. Do not add volcanic stone around base. Volcanic Stone and debris could fall into the control area of fireplace.
- This fireplace is designed to be smokeless. If logs ever appear to smoke, turn off fireplace and call a gualified service person.

**NOTE**: During initial operation, slight smoking could occur due to log curing and fireplace burning manufacturing residues.

- To prevent the creation of soot, follow the instructions in <u>Cleaning and Maintenance</u>, **Page** 27.
- Before using furniture polish, wax, carpet cleaner, or similar products, turn fireplace off. If heated, the vapors from these products may

create a white powder residue within burner box or on adjacent walls or furniture.

- This fireplace needs fresh air ventilation to run properly. This fireplace has an Oxygen Depletion Sensing (ODS) safety shutoff system. The ODS shuts down the fireplace if not enough fresh air is available. See <u>Air for Combustion and Ventilation</u>, **Page 7**. If fireplace keeps shutting off, see <u>Troubleshooting</u>, **Page 29**.
- 11. Do not run fireplace
- where flammable liquids or vapors are used or stored.
- under dusty conditions.
- 12. Do not use this fireplace to cook food or burn paper or other objects.
- 13. Never place any objects in the fireplace or on logs.
- 14. Do not use fireplace if any part has been under water. Immediately call a qualified service technician to inspect the room fireplace and to replace any part of the control system and any gas control which has been under water.
- 15. Turn off and unplug fireplace and let cool before servicing. Only a qualified service person should service and repair fireplace.
- 16. Operating fireplace above elevations of 4,500 feet could cause pilot outage.
- 17. Do not operate fireplace if any log is broken. Do not operate fireplace if a log is chipped (dimesized or larger).
- To prevent performance problems, do not use propane/LP fuel tank of less than 100 lbs. capacity.
- 19. Provide adequate clearances around air openings.
- 20. The screen or any other part removed for servicing must be replaced prior to operating this heater.




Figure 1 - Vent-Free Compact Classic Hearth® Fireplace

## **LOCAL CODES**

Install and use fireplace with care. Follow all local codes. In the absence of local codes, use the latest edition of *The National Fuel Gas Code, ANSI Z223.1/ NFPA 54*\*. Firebox must be electrically grounded in accordance with the *National Electrical Code, ANS/ NFPA70* (latest edition). \*Available from:

#### COMMONWEALTH OF MASSACHUSETTS REQUIREMENTS

These appliances are approved for installation in the US state of Massachusetts if the following additional requirements are met:

- Un-vented Room Heaters shall be installed in accordance with 527 CMR 30.
- Installation and repair must be done by a plumber or gas fitter licensed in the Commonwealth of Massachusetts.
- The flexible gas line connector used shall not exceed 36 inches (92 centimeters) in length.
- The individual manual shut-off must be a T-handle type valve.
- Unvented appliances may NOT be installed in bedrooms or bathrooms.

• A working smoke detector must be installed in the area where vent-free appliances are installed. Seller of unvented propane or natural gas-fired supplemental room heaters shall provide to each purchaser a copy of 527 CMR 30 upon sale of the unit.

## **PRODUCT FEATURES**

#### SAFETY PILOT

This fireplace has a pilot with an Oxygen Depletion Sensing (ODS) safety shutoff system. The ODS/pilot is a required feature for vent-free room fireplaces. The ODS/pilot shuts off the fireplace if there is not enough fresh air.

#### **PIEZO IGNITION SYSTEM**

This fireplace has a piezo igniter. This system requires no matches, batteries, or other sources to light fireplace.

- 1. Remove fireplace and hood from carton. Log is wrapped and inside fireplace. Do not remove at this time.
- 2. Remove all protective packaging applied to fireplace for shipment.

3. Make sure your fireplace includes one hardware packet.

4. Check all items for any shipping damage. If damaged, promptly inform dealer where you purchased the fireplace.

## ASSEMBLY

WARNING: Always have branch support and screen in place before operating fireplace. This prevents excessive temperatures on fireplace surfaces.

WARNING: Failure to position the parts in accordance with these diagrams or failure to use only parts specifically approved with this fireplace may result in property damage or personal injury.

## **ASSEMBLING FIREPLACE**

Tools Required:

- Phillips screwdriver
- 5/16" hex wrench
- slotted screwdriver
- scissors
- 1. Remove two screws that hold fireplace screen in place for shipping. These screws are located near top of screen. Discard screws. Lift fireplace screen up and pull out to remove. Set screen aside until installation has been completed.
- 2. Cut two plastic straps to remove the log from the firebox cavity.
- An optional blower is available. See Accessories, Page 34. Install optional blower now. Follow installation instructions provided with blower or (see Page 15).

4. Locate four black phillips sheet metal screws from the hardware packet.





Figure 2 - Removing Screen

- 5. Rotate hood as shown in Figure 3. Make sure hood tabs point toward fireplace.
- 6. Insert hood tabs between baffle and louvers *(see Figure 3, Page 7).*
- 7. Gently rotate hood to upright position. Make sure hood tabs are behind louvers and hood is resting on firebox top (*see Figure 3*).
- 8. Align screw holes on hood with screw holes on firebox top.
- 9. Insert screws as shown in *Figure 3.* Tighten screws firmly.

## **AIR FOR COMBUSTION AND VENTILATION**

WARNING: This heater shall not be installed in a room or space unless the required volume of indoor combustion air is provided by the method described in the National Fuel Gas Code, ANSI Z223.1/NFPA54, the International Fuel Gas Code, or applicable local codes. Read the following instructions to ensure proper fresh air for this and other fuel-burning appliances in your home.

Today's homes are built more energy efficient than ever. New materials, increased insulation and new construction methods help reduce heat loss in homes. Homeowners apply weather strip and caulk around windows and doors to keep the cold air out and the warm air in. During heating months, homeowners want their homes as airtight as possible.

While it is good to make your home energy efficient, your home needs to breathe. Fresh air must enter your home. All fuel-burning appliances need fresh air for proper combustion and ventilation.

Exhaust fans, some fireplaces, clothes dryers and some fuel-burning appliances draw air from the house to operate. You must provide adequate fresh air for these appliances. This will ensure proper venting of vented fuel-burning appliances.

#### **PROVIDING ADEQUATE VENTILATION**

The following are excerpts from *National Fuel Gas Code ANS Z223.1/NFPA 54,Air for Combustion and Ventilation*.

All spaces in homes fall into one of the three following ventilation classifications:

- 1. Unusually Tight Construction
- 2. Unconfined Space
- 3. Confined Space

The information on *Pages 7 Through 9* will help you classify your space and provide adequate ventilation.

#### **Unusually Tight Construction**

The air that leaks around doors and windows may provide enough fresh air for combustion and ventilation. However, in buildings of unusually tight construction, you must provide additional fresh air. Unusually tight construction is defined as construction where:

- a. walls and ceilings exposed to the outside atmosphere have a continuous water vapor retarder with a rating of one perm (6 x 10<sup>-11</sup> kg per pa-sec-m<sup>2</sup>) or less with openings gasketed or sealed and
- b. weather stripping has been added on openable windows and doors and
- c. caulking or sealants are applied to areas such as joints around window and door frames, between sole plates and floors, between wall-ceiling joints, between wall panels, at penetrations for plumbing, electrical and gas lines and at other openings.

If your home meets all of the three criteria above, you must provide additional fresh air. See <u>Ventila-</u> <u>tion Air From Outdoors</u>, Page 9.

If your home does not meet all of the three criteria above, proceed to <u>Determining Fresh-Air Flow for</u> <u>Firebox Location</u>, Page 8.

#### **Confined and Unconfined Space**

The National Fuel Gas Code, ANSI Z223.1/NFPA54 allows two methods for determining whether the space in which the heater is being installed is confined or unconfined space. The standard method defines a confined space as a space whose volume is less than 50 cubic feet per 1,000 Btu/hr (4.8 m<sup>3</sup> per kw) of the aggregate input rating of all appliances installed in that space and an unconfined space as a space whose volume is not less than 50 cubic feet per 1,000 Btu/hr (4.8 m<sup>3</sup> per kw) of the aggregate input rating of all appliances installed in that space. Rooms communicating directly with the space in which the appliances are installed\*, through openings not furnished with doors, are considered a part of the unconfined space.

This appliance shall not be installed in a confined space or unusually tight construction unless provisions are provided for adequate combustion and ventilation air.

Where the air infiltration rate of a structure is known, the Known Air Infiltration Rate Method may be used. Follow The National Fuel Gas Code, ANSI Z223.1/NFPA 54 to use this method to determine if the space is confined or unconfined.

\* Adjoining rooms are communicating only if there are doorless passageways or ventilation grills between them.

## AIR FOR COMBUSTION AND VENTILATION Continued

#### DETERMINING FRESH-AIR FLOW FOR FIREBOX LOCATION

#### Determining if You Have a Confined or Unconfined Space Using the Standard Method

Use this work sheet to determine if you have a confined or unconfined space.

**Space:** Includes the room in which you will install appliance plus any adjoining rooms with doorless passageways or ventilation grills between the rooms.

1. Determine the volume of the space (length x width x height).

Length x Width x Height =\_\_\_\_cu. ft. (volume of space)

**Example**: Space size 22 ft. (length) x 18 ft. (width) x 8 ft. (ceiling height) = 3168 cu. ft. (volume of space)

If additional ventilation to adjoining room is supplied with grills or openings, add the volume of these rooms to the total volume of the space.

2. Multiply the space volume by 20 to determine the maximum Btu/Hr the space can support.

\_\_\_\_\_ (volume of space) x 20 = (Maximum Btu/Hr the space can support)

*Example:* 3168 cu. ft. (volume of space) x 20 = 63,360 (maximum Btu/Hr the space can support)

3. Add the Btu/Hr of all fuel burning appliances in the space.

Gas water appliance*		_ Btu/Hr
Gas furnace		_ Btu/Hr
Vented gas appliance		_ Btu/Hr
Gas fireplace logs		_ Btu/Hr
Other gas appliances*	+	_ Btu/Hr
Total	=	_ Btu/Hr

\* Do not include direct-vent gas appliances. Directvent draws combustion air from the outdoors and vents to the outdoors.

#### Example:

Gas water appliance		30,000	Btu/Hr
Gas firebox logs	+	10,000	Btu/Hr
Total	=	40,000	Btu/Hr

4. Compare the maximum Btu/Hr the space can support with the actual amount of Btu/Hr used.

\_\_\_\_\_Btu/Hr (maximum the space can support) \_\_\_\_\_Btu/Hr (actual amount of Btu/Hr used)

*Example:* 35,840 Btu/Hr (maximum the space can support) 40,000 Btu/Hr (actual amount of Btu/ Hr used)

The space in the above example is a confined space because the actual Btu/Hr used is more than the maximum Btu/Hr the space can support. You must provide additional fresh air. Your options are as follows:

- Rework work sheet, adding the space of an adjoining room. If the extra space provides an unconfined space, remove door to adjoining room or add ventilation grills between rooms. See <u>Ventilation Air from Inside Building</u>, **Page** *9*.
- B. Vent room directly to the outdoors. See <u>Ventila-</u> <u>tion Air from Outdoors</u>, **Page 9**.
- C. Install a lower Btu/Hr gas log appliance, if lower Btu/Hr size makes room unconfined.

If the actual Btu/Hr used is less than the maximum Btu/Hr the space can support, the space is an unconfined space. You will need no additional fresh air ventilation.

WARNING: If the area in which the appliance may be operated does not meet the required volume for indoor combustion air, combustion and ventilation air shall be provided by one of the methods described in the National Fuel Gas Code, ANSI Z223.1/NFPA 54, the International Fuel Gas Code, or applicable local codes.

#### AIR FOR COMBUSTION AND VENTILATION Continued

#### **VENTILATION AIR**

#### Ventilation Air From Inside Building




Figure 4 - Ventilation Air from Inside Building

This fresh air would come from an adjoining unconfined space. When ventilating to an adjoining unconfined space, you must provide two permanent openings: one within 12" of the ceiling and one within 12" of the floor on the wall connecting the two spaces (see options 1 and 2, **Figure 4**). You can also remove door into adjoining room (see option 3, **Figure 4**). Follow the National Fuel Gas Code, ANSI Z223.1/NFPA 54, Air for Combustion and Ventilation for required size of ventilation grills or ducts.

#### **Ventilation Air From Outdoors**

Provide extra fresh air by using ventilation grills or ducts. You must provide two permanent openings: one within 12" of the ceiling and one within 12" of the floor. Connect these items directly to the outdoors or spaces open to the outdoors. These spaces include attics and crawl spaces. Follow the *National Fuel Gas Code, ANSI Z223.1/NFPA 54, Air for Combustion and Ventilation* for required size of ventilation grills or ducts.

**IMPORTANT**: Do not provide openings for inlet or outlet air into attic if attic has a thermostatcontrolled power vent. Heated air entering the attic will activate the power vent.




Figure 5 - Ventilation Air from Outdoors

NOTICE: This appliance is intended for supplemental heating. Use this appliance along with your primary heating system. Do not install this appliance as your primary heat source. If you have a central heating system, you may run system's circulating blower while using appliance. This will help circulate the heat throughout the house. In the event of a power outage, you can use this appliance as your primary heat source.

WARNING: A qualified service person must install appliance. Follow all local codes.

A WARNING: Never install the fireplace

- in a bathroom or bedroom
- in a recreational vehicle
- where curtains, furniture, clothing, or other flammable objects are less than 36" from the front, top, or sides of the fireplace
- as a fireplace insert
- in high traffic areas
- in windy or drafty areas

CAUTION: This fireplace creates warm air currents. These currents move heat to wall surfaces next to fireplace. Installing fireplace next to vinyl or cloth wall coverings or operating fireplace where impurities (such as, but not limited to, tobacco smoke, aromatic candles, cleaning fluids, oil or kerosene lamps, etc.) in the air exist, may discolor walls or cause odors.

*IMPORTANT:* Vent-free fireplaces add moisture to the air. Although this is beneficial, installing fireplace in rooms without enough ventilation air may cause mildew to form from too much moisture. See <u>Air for Combustion and Ventilation</u>, **Page 7**.

**NOTE**: Your fireplace is designed to be used in zero clearance installations. Wall or framing material can be placed directly against any exterior surface on the rear, sides, or top of your fireplace, except where standoff spacers are integrally attached. If standoff spacers are attached to your fireplace, these spacers can be placed directly against wall or framing materials.

**NOTE**: When installing fireplace directly on carpeting, tile or other combustible material, other than wood flooring, the fireplace shall be installed on a metal or wood panel extending the full width and depth of the fireplace.

Use the dimensions shown for rough openings to create the easiest installation *(see <u>Built-In Fireplace</u> Installation, Page 11).* 

## **CHECK GAS TYPE**

Use the correct gas type (natural or propane/LP) for your unit. If your gas supply is not correct, do not install fireplace. Call dealer where you bought fireplace for proper type fireplace.

WARNING: This appliance is equipped for either natural gas or propane/LP gas but not both. Gas type is indicated on the rating plate. Field conversion is not permitted.

## **INSTALLATION ITEMS**

Before installing fireplace, make sure you have the items listed below.


- external regulator (supplied by installer, for propane/LP units only)
- piping (check local codes)
- sealant (resistant to propane/LP gas)
- equipment shutoff valve \*
- test gauge connection\*
- ground joint union
- sediment trap
- tee joint
- pipe wrench

\* An equipment shutoff valve with 1/8" NPT tap is an acceptable alternative to test gauge connection. Purchase the optional equipment shutoff valve from your dealer.

**NOTE**: If desired, purchase a three-sided trim kit for built-in installations. See <u>Accessories</u>, **Page 34**.

## **INSTALLATION** Continued

## FIREPLACE CLEARANCES



If your fireplace is to be used with an optional mantel, the installation instructions included with your mantel shows an approved method of attaching the fireplace/mantel system to a wall. **IMPORTANT**: Only use optional cabinet or corner mantels specified in this manual. Purchase the optional mantel from your dealer (see <u>Accessories</u>, **Page 34**).

If your fireplace is to be recessed into the wall, see <u>Built-In Fireplace Installation</u> to secure your fireplace into the wall.

# **CAUTION:** If you install the fireplace in a home garage


- fireplace pilot and burner must be at least 18" above floor.
- locate fireplace where moving vehicle will not hit it.

For convenience and efficiency, install fireplace

- where there is easy access for operation, inspection, and service
- in coldest part of room

An optional blower kit is available from your dealer. See <u>Accessories</u>, **Page 34**. If planning to use blower, follow instructions provided with blower for power source.

Maintain adequate clearances for accessibility for purposes of servicing and proper operation.

#### Minimum Clearances For Side Combustible Material, Side Wall, and Ceiling

A. Clearances from the side of the fireplace cabinet to any combustible material and wall should follow diagram in *Figure 6*.

**Example**: The face of a mantel, bookshelf, etc. is made of combustible material and protrudes 3-1/2" from the wall. This combustible material must be 4" from the side of the fireplace opening *(see Figure 6)*.

- B. Clearances from the top of the fireplace opening to the ceiling should not be less than 36".
- C. For mantel clearances, see *Figure 10 on Page 13*.

MINIMUM CLEARANCE TO COMBUSTIBLE MATERIALS

## **BUILT-IN FIREPLACE INSTALLATION**

Built-in installation of this fireplace involves installing fireplace into a framed-in enclosure. This makes the front of fireplace flush with wall. An optional trim kit accessory is available *(see <u>Accessories</u>, Page 34). Trim will extend past sides of fireplace approximately 1/2". This will cover the rough edges of the wall opening. If installing a built-in mantel above the fireplace, you must follow the clearances shown in <i>Figure 10, Page 13*. Follow the instructions below to install the fireplace in this manner.




Figure 7 - Rough Opening for Installing in Wall




Figure 8 - Rough Opening for Installing in Corner

- Frame in rough opening. Use dimensions shown in *Figure 7, Page 12* for the rough opening. If installing in a corner, use dimensions shown in *Figure 8, Page 12* for the rough opening. The height is 26-7/8" which is the same as the wall opening above.
- 2. If installing GA3450TA blower accessory, do so at this time. Follow instructions included with blower accessory.

### INSTALLATION Continued

**NOTE**: If not installing blower accessory, you may wish to run electrical wiring to your fireplace for future blower installation (see <u>Accessories</u>, **Page 34**). Use only approved three-wire electrical wiring.

**NOTE**: A qualified installer should make all electrical connections.

WARNING: If pre-wiring, do not connect wiring to any electrical source at this time.

Install fireplace electrical outlet and connect wiring to outlet before connecting to electrical source. The fireplace electrical outlet is included with the GA3450TA blower accessory.

Only use the fireplace electrical outlet supplied with the GA3450TA blower accessory.

3. Install gas piping to fireplace location. This installation includes an approved flexible gas line (if allowed by local codes) after the equipment shutoff valve. The flexible gas line must be the last item installed on the gas piping.

- 4. If you have not assembled firebox, follow instructions beginning on *Page 5*.
- 5. Carefully set fireplace in front of rough opening with back of fireplace inside wall opening.
- Attach flexible gas line to fireplace gas regulator. See <u>Connecting Fireplace to Gas Supply</u>, **Page 18**.




Figure 9 - Attaching Fireplace to Wall Studs

- 7. Bend four nailing flanges on outer casing with pliers (see **Figure 9**).
- 8. Attach fireplace to wall studs using nails or wood screws through holes in nailing flange.
- 9. Check all gas connections for leaks. See <u>Check-ing Gas Connections</u>, **Page 20**.
- If using optional trim kit, install the trim after final finishing and/or painting of wall. See instructions included with trim accessory for attaching trim.

**IMPORTANT**: When finishing your firebox, combustible materials such as wall board, gypsum board, sheet rock, drywall, plywood, etc. may be butted up next to the sides and top edge of the firebox. Combustible materials should never overlap the firebox front facing.

WARNING: Do not allow any combustible or noncombustible materials to overlap the firebox front facing.

WARNING: Do not allow noncombustible materials to cover any necessary openings like louvered slots.

WARNING: Never modify or cover the louvered slots on the front of the firebox.

#### Mantel Clearances for Built-In Installation


If placing mantel above built-in fireplace, you must meet minimum clearance between mantel shelf and top of fireplace opening.

NOTICE: Surface temperatures of adjacent walls and mantels become hot during operation. Walls and mantels above the firebox may become hot to the touch. If installed properly, these temperatures meet the requirement of the national product standard. Follow all minimum clearances shown in this manual.

NOTICE: If your installation does not meet the minimum clearances shown in *Figure 10*, you must do one of the following:

- raise the mantel to an acceptable height
- remove the mantel

Minimum clearance requirements include any projections such as shelves, window sills, mantels, etc. above the appliance.

## **OPTIONAL MANTEL INSTALLATION**

Refer to instructions provided with the mantel for assembly instructions. Refer to the following instructions for system installation. Refer to instructions on *Page 7* for hood assembly. Blower accessory should be installed prior to mantel if it is being used *(see Installing Optional Blower Accessory GA3450TA, Page 15)*.

- 1. Assemble cabinet mantel as shown in accessory instruction sheet.




Figure 11 - Placing Hearth Base Against Wall

- 2. If blower is installed, install a properly grounded, 120 volt three-prong electrical outlet at fireplace location if an outlet is not there. If possible, locate outlet so cabinet mantel will cover it when installed *(see Figure 11).*
- 3. Place hearth base against wall at installation location. Cut an access hole in hearth base to run gas line to fireplace *(see Figure 11)*. Make sure to locate access hole so cabinet mantel will cover it when installed.

**NOTE**: You can secure base to floor using wood screws. Countersink screw heads and putty over.

- 4. Route flexible gas line through access hole in hearth base.




Figure 12 - Installing Cabinet Mantel onto Hearth Base

- 5. Center cabinet mantel on hearth base *(see Figure 12)*. Make sure mantel is flush against wall and centered left to right on base.
- 6. Use screws provided with mantel accessory to attach mantel assembly to base (see mantel instruction sheet).
- 7. Attach flexible gas line to fireplace gas regulator. See *Connecting to Gas Supply*, **Page 18**.
- 8. Route electrical cord(s) through access holes in either side of fireplace with bushing. Plug electrical cord(s) into electrical outlet.
- 9. Check all gas connections for leaks. See <u>Check-ing Gas Connections</u>, **Page 20**.




Figure 13 - Installing Fireplace into Mantel Assembly

- 10. Carefully insert fireplace into cabinet mantel *(see Figure 13)*. Be careful not to scratch or damage hearth base or cabinet mantel.
- Place metal trim on shoulder screws located on the side and top of the fireplace (see <u>Assembling</u> <u>Perimeter Trim</u>). Firmly snap trim over shoulder screws. Align fireplace in mantel assembly so the trim overlaps mantel evenly on all three sides.
- 12. Lower bottom louver door. Use 3" wood screws provided with mantel accessory to attach fireplace to base (see mantel instruction sheet).

#### **Assembling Perimeter Trim**

- 1. Remove packaging from three remaining pieces of trim.
- 2. Locate two adjusting plates with set screws, and two shims in the hardware packet.




Figure 14 - Assembling Perimeter Trim

- 3. Align shim under adjusting plate as shown in *Figure 14*.
- 4. Slide one end of adjusting plate/shim in slot on mitered edge of top trim *(see Figure 14).*
- 5. Slide other end of adjusting plate/shim in slot on mitered edge of side trim *(see Figure 14)*.
- 6. While firmly holding edges of trim together, tighten both set screws on the adjusting plate with slotted screwdriver.
- 7. Repeat steps 1 through 6 for other corner.
- 8. Set assembly aside for later installation.

#### INSTALLING OPTIONAL BLOWER ACCESSORY GA3450TA

## Removing Upper Louver Assembly and Branch Support

To install the blower accessory, you must first remove the upper louver assembly.

- 1. Lift screen off fireplace and remove log set if installed.




Figure 15 - Removing Top Louver and Branch Support

- 2. Remove 2 screws from each side of branch support and pull branch support out *(see Figure 15)*.
- 3. Remove 4 screws from upper louver assembly *(see Figure 15)*. Save these screws.
- 4. Pull upper louver assembly straight out from the cabinet. Be careful not to scratch the paint. Set louver assembly and screws aside.
- 5. Open lower louver door by swinging door down *(see Figure 15).*

#### Installing Blower Accessory

**CAUTION:** Label all wires prior to disconnection when servicing controls. Wiring errors can cause improper and dangerous operation.

# **CAUTION:** Verify proper operation after servicing.

**NOTE**: If you are using a mantel with your fireplace, use the following instructions. If your fireplace is built-in, see *For Built-In Installation*, **Page 17**.

- 1. Install snap bushings found in hardware kit into both holes in rear of valve cover shield.
- 2. Make sure the wire harness is firmly connected to the terminals on the blower bracket assembly.




Figure 16 - Installing Blower Bracket Assembly

- Note the wire locations on back of AUTO/OFF/ ON switch. The terminals on back of switch are numbered 1, 2, and 3. Carefully remove red wire from terminal 3 and blue wire from terminal 1. Black wire can remain on middle terminal 2 (see Figure 16, Page 16).




Figure 17 - Wiring Diagram For Blower Accessory Standard Installation

- 4. Carefully disconnect green and white wires at their insulated connectors *(see Figure 17, Page 16).*
- 5. In top of the fireplace cabinet, locate the four mounting holes on the outer casing. Align these four holes with those on the blower bracket assembly. Attach blower bracket assembly to the outer casing with 4 #10 screws provided (see Figure 16, Page 16).
- 6. Route the wire harness through the hole in left side of baffle. Pull wire harness through lower opening on the side of the valve cover shield *(see Figure 16, Page 16).*
- 7. Insert the 4 wire harnesses into one of the round holes in the rear of the valve cover shield and through the rectangular hole in the front of shield *(see Figure 16, Page 16)*.
- 8. Reconnect red wire to switch position 3. Reconnect blue wire to switch position 1. Reconnect green and white wires.




Figure 18 - Installing Switch Plate to Valve Cover Shield

- Install the switch plate on the valve cover shield with 2 #10 screws provided (see Figure 18, Page 16). Route power cord out of the cabinet by inserting it through the bushing on the outer casing (see Figure 16, Page 16). Plug fan kit into 120-Volt grounded power supply and test operation.

**NOTE**: When switch is in the AUTO position, the fan will start after the fireplace has run for a few moments. The fan will continue to run for several moments after the fireplace has been turned off. When switch is in the ON position, the fan will run until turned to OFF. Reinstall upper louver assembly (see **Figure 15**) and branch support. Close lower louver door. INSTALLATION Continued

For Built-In Installation

WARNING: A licensed electrician must connect the wiring harness to electrical supply following all local codes. Electrician must provide a clamp on the box cover to secure the wiring. Wiring should be routed through the bushing in the hole on the outer casing of fireplace.

 Install a snap bushing found in hardware kit into one of the holes on rear of valve cover shield. The other hole is for a strain relief clamp (not supplied) to secure incoming electrical supply.

- 2. Follow steps 2 through 6 in *Installing Blower* <u>Accessory</u>, **Page 15**.




Figure 19 - Wiring Diagram For Blower Accessory Built-In Installation

- 3. A licensed electrician must follow the wiring diagram to connect incoming electrical supply to fan kit wiring harness *(see Figure 19).*




Figure 20 - Installing Blower Bracket Assembly

- Plug power cord to the outlet receptacle (not provided) as shown in *Figure 20*. Wind the extra power cord and tie with plastic wire strap (*see Figure 20*). Set the power cord bundle between the burner bracket and outer casing, away from the burner.
- 5. Test to make sure the blower is working properly.
- 6. Reinstall upper louver assembly *(see Figure 15, Page 15)* and close lower louver.

#### **Extension Cord**

Use extension cord if needed. The cord must have a three-prong, grounding plug and a three-hole receptacle. Make sure cord is in good shape. It must be heavy enough to carry the current needed. An undersized cord will cause a drop in line voltage. This will result in loss of power and overheating. Use a No. 16 AWG cord for lengths less than 50 feet.

## CONNECTING TO GAS SUPPLY

WARNING: This appliance requires a 45° male flare fitting 5/8"-18 UNF (Unified National Fine Thread) inlet connection and the flexible gas line provided.

WARNING: A qualified service person must connect appliance to gas supply. Follow all local codes.

WARNING: Never connect this appliance to private (non-utility) gas wells. This gas is commonly known as wellhead gas and does not have odorants and may have impurities, and variations in BTU content. The use of well-head gas will void the manufacturer's warranty to this appliance.

*IMPORTANT:* For natural gas, check gas line pressure before connecting fireplace to gas line. Gas line pressure must be no greater than 14" of water. If gas line pressure is higher, heater regulator damage could occur.

**CAUTION:** Never connect propane/ LP fireplace directly to the propane/ LP supply. This heater requires an external regulator (not supplied). Install the external regulator between the heater and propane/LP supply.





Figure 21 - External Regulator With Vent Pointing Down

For propane/LP units, the installer must supply an external regulator. The external regulator will reduce incoming gas pressure. You must reduce incoming gas pressure to between 11" and 14" of water. If you do not reduce incoming gas pressure, fireplace regulator damage could occur. Install external regulator with the vent pointing down as shown in *Figure 21*. Pointing the vent down protects it from freezing rain or sleet.

**CAUTION:** Use only new, black iron or steel pipe. Internally-tinned copper tubing may be used in certain areas. Check your local codes. Use pipe of 1/2" diameter or greater to allow proper gas volume to heater. If pipe is too small, undue loss of volume will occur.

Installation must include an equipment shutoff valve, union, and plugged 1/8" NPT tap. Locate NPT tap within reach for test gauge hook up. NPT tap must be upstream from heater *(see Figure 22, Page 19)*.

*IMPORTANT:* Install equipment shutoff valve in an accessible location. The equipment shutoff valve is for turning on or shutting off the gas to the appliance.

Check your building codes for any special requirements for locating equipment shutoff valve to fireplaces.

Apply pipe joint sealant lightly to male NPT threads. This will prevent excess sealant from going into pipe. Excess sealant in pipe could result in clogged fireplace valves.

WARNING: Use pipe joint sealant that is resistant to liquid petroleum (LP) gas.

## INSTALLATION Continued

We recommend that you install a sediment trap in supply line as shown in Figure 22. Locate sediment trap where it is within reach for cleaning. Install in piping system between fuel supply and heater. Locate sediment trap where trapped matter is not likely to freeze. A sediment trap traps moisture and contaminants. This keeps them from going into fireplace controls. If sediment trap is not installed or is installed wrong, fireplace may not run properly.





\* Purchase the optional equipment shutoff valve from your dealer.

#### CONNECTING FIREPLACE TO GAS SUPPLY Installation Items Needed

- · Phillips screwdriver
- sealant (resistant to propane/LP gas, not provided)





Figure 23 - Removing Branch Support From Fireplace

- 1. Remove screws that attach branch support to fireplace *(see Figure 23)*. Carefully lift up branch support and remove from fireplace *(see Figure 23)*.

NOTICE: Most building codes do not permit concealed gas connections. A flexible gas line is provided to allow accessibility from the fireplace *(see Figure 23)*. The flexible gas supply line connection to the equipment shutoff valve should be accessible.

- 2. Route flexible gas line, included, from fireplace control to equipment shutoff valve through side or rear access holes in outer casing.
- 3. Apply pipe joint sealant lightly to male threads of gas connector attached to flexible gas line/ equipment shutoff valve (see Figure 24).

# **CAUTION:** Avoid damage to gas control. Hold gas control with wrench when connecting it to gas piping and/ or fittings.

- 4. Check all gas connections for leaks. See <u>Check-ing Gas Connections</u>, **Page 20**.
- 5. Replace branch support back into fireplace. Feed flexible gas line into fireplace base area while replacing branch support. Make sure the entire flexible gas line is in fireplace base area. Reattach branch support to fireplace with screws removed in step 1.

## **CHECKING GAS CONNECTIONS**

WARNING: Test all gas piping and connections, internal and external to unit, for leaks after installing or servicing. Correct all leaks at once.

WARNING: Never use an open flame to check for a leak. Apply a noncorrosive leak detection fluid to all joints. Bubbles forming show a leak. Correct all leaks at once.

**CAUTION:** Make sure external regulator has been installed between propane/LP supply and appliance. See guidelines under <u>Connecting to Gas</u> <u>Supply</u>, Page 18.

# PRESSURE TESTING GAS SUPPLY PIPING SYSTEM

The appliance and its appliance main gas valve must be disconnected from the gas supply piping system during any pressure testing of that system at test pressures **in excess of** 1/2 psi (3.5 kPa).

The appliance must be isolated from the gas supply piping system by closing its equipment shutoff valve during any pressure testing of the gas supply piping system at test pressures **equal** to or less than 1/2 psi (3.5 kPa).

#### Test Pressures In Excess Of 1/2 PSIG (3.5 kPa)

- 1. Disconnect appliance with its appliance main gas valve (control valve) and equipment shutoff valve from gas supply piping system. Pressures in excess of 1/2 psig (3.5 kPA) will damage heater regulator.
- 2. Cap off open end of gas pipe where equipment shutoff valve was connected.
- 3. Pressurize supply piping system by either opening propane/LP supply tank valve for propane/LP gas or opening main gas valve located on or near gas meter for natural gas, or using compressed air.
- 4. Check all joints of gas supply piping system. Apply noncorrosive leak detection fluid to all joints. Bubbles forming show a leak.
- 5. Correct all leaks at once.
- 6. Reconnect fireplace and equipment shutoff valve to gas supply. Check reconnected fittings for leaks.

# Test Pressures Equal To or Less Than 1/2 PSIG (3.5 kPa)




Figure 25 - Equipment Shutoff Valve

- 1. Close equipment shutoff valve (see Figure 25).
- 2. Pressurize supply piping system by either opening propane/LP supply tank valve for propane/LP gas or opening main gas valve located on or near gas meter for natural gas, or using compressed air.




Figure 26 - Checking Gas Joints (Propane/LP Only)

- 3. Check all joints from gas meter to equipment shutoff valve for natural gas or propane/LP supply to equipment shutoff valve for propane/LP *(see Figures 26 or 27)*. Apply noncorrosive leak detection fluid to all joints. Bubbles forming show a leak.
- 4. Correct all leaks at once.




Figure 27 - Checking Gas Joints for Natural Gas (Shown with Optional Mantel)


#### PRESSURE TESTING FIREPLACE GAS CONNECTIONS

- 1. Open equipment shutoff valve (see Figure 25, Page 20).
- 2. Open main gas valve located on or near gas meter for natural gas or open propane/LP supply tank valve.
- 3. Make sure control knob of fireplace is in the OFF position.
- 4. Check all joints from equipment shutoff valve to gas control valve (see Figures 26 or 27. Page 20). Apply noncorrosive leak detection fluid to all joints. Bubbles forming show a leak.
- 5. Correct all leaks at once.
- 6. Light fireplace (see Operation, Page 23). Check all other internal joints for leaks.
- 7. Turn off fireplace (see To Turn Off Gas to Appliance, Page 24).

## **OPTIONAL WIRELESS HAND-HELD REMOTE CONTROL ACCESSORIES (MRC** AND TRC)

#### Installing Receiver

- 1. Remove screws.
- 2. Disconnect switch wires from control valve.
- 3. Remove switch plate (see Figure 28). Discard switch plate after removing. Save the screws.
- 4. Place remote receiver unit onto fireplace base.
- 5. Connect the wire harness from the receiver to the TH and TH/TP terminals on the valve.
- 6. For further information see installation instructions provided with remote control kit.






#### **OPTIONAL WALL MOUNTED THERMOSTAT** - GWMT1

WARNING: Read and follow installation instructions. Installation should be done by a qualified installer familiar with low-voltage wiring procedures.

## A WARNING: Do not connect this thermostat to any electrical source! Electrical shock and/or fire hazard will occur.

- 1. Connect one terminal of 25 ft. wire to bottom contact of switch (see Figure 29).
- 2. Connect remaining wire terminal to "TH" terminal on control valve. Make sure that wire terminals are in the positions on your unit as pictured in Figure 29. If wires are not "crossed" thermostat will not work.

3. Route 25 ft. wire to a convenient location to mount your thermostat (no outside wall). IM-**PORTANT**: Wire may be shortened but must not be lengthened.


Thermostat should be mounted 54" above the floor in a location where there is good air circulation. Avoid heat sources such as lamps, direct sunlight, fireplace, or heat and air conditioning ducts.

- 4. Gently remove thermostat cover from base. Grasp sides of cover firmly and pull to separate from base.




Figure 30 - Back View of Thermostat Base

- 5. Feed electrical wires through rectangular slots on each side of base (see Figure 30).

# WARNING: Do not connect the thermostat to a power source. Electrical shock and/or a fire hazard will occur.




Figure 31 - Thermostat Base Terminals "W" and "R"

- 6. Connect one bare wire end to each terminal ("W" and "R") of the thermostat base (see *Figure 31*).
- 7. Install base onto wall with provided screws.

- 8. Move temperature adjustment back and forth to ensure bimetal is free from restrictions.
- 9. Replace cover onto base. (Upon installation, thermostat must be allowed to stabilize at room temperature for a minimum of 30 minutes for proper operation).
- 10. Set switch on fireplace to Auto position.
- 11. Set temperature adjustment to desired setting. This thermostat has been electronically calibrated at the factory. No adjustment or leveling is necessary.

## **OPTIONAL WALL SWITCH - GWMS2**

WARNING: Read and follow installation instructions. Installation should be done by a qualified installer familiar with low-voltage wiring procedures.

WARNING: Do not connect this switch to any electrical source! Electrical shock and/or fire hazard will occur.

- 1. Connect one terminal of 25 ft. wire to bottom contact of switch *(see Figure 29, Page 21).*
- Connect remaining wire terminal to "TH" terminal on control valve. Make sure that wire terminals are in the positions on your unit as pictured in *Figure 29, Page 21*. If wires are not "crossed" thermostat will not work.
- 3. Route 25 ft. wire to a convenient location to mount your wall switch (no outside walls).

WARNING: Do not connect the switch to a power source. Electrical shock and/or fire hazard will occur.

*IMPORTANT:* Wire may be shortened but must not be lengthened.

- 4. Connect one bare wire end to each of the terminals of provided wall switch.
- 5. Install wall switch and cover in wall.

## **INSTALLING LOG SET AND SCREEN**




Figure 32 - Installing Log and Screen

- 1. Remove log packaging material and discard packaging. Gently place log on burner support *(see Figure 32).* Log should fit flat against top of burner support and log locator tabs fit into slots under log. Do not allow log to contact flame. If flame contacts log, soot will be created.
- 2. Reattach screen by placing notches in screen frame over shoulder screws and pushing down.

## **OPERATION**

FOR YOUR SAFETY READ BEFORE LIGHTING

WARNING: If you do not follow these instructions exactly, a fire or explosion may result causing property damage, personal injury or loss of life.

- A. This appliance has a pilot which must be lighted by hand. When lighting the pilot, follow these instructions exactly.
- B. BEFORE LIGHTING smell all around the appliance area for gas. Be sure to smell next to the floor because some gas is heavier than air and will settle on the floor.

## **OPERATION**

WHAT TO DO IF YOU SMELL GAS

- Do not try to light any appliance.
- Do not touch any electric switch; do not use any phone in your building.
- Immediately call your gas supplier from a neighbor's phone. Follow the gas supplier's instructions.
- If you cannot reach your gas supplier, call the fire department.
- C. Use only your hand to push in or turn the gas control knob. Never use tools. If the knob will not push in or turn by hand, don't try to repair it, call a qualified service technician or gas supplier. Force or attempted repair may result in a fire or explosion.
- D. Do not use this appliance if any part has been under water. Immediately call a qualified service technician to inspect the appliance and to replace any part of the control system and any gas control which has been under water.

### LIGHTING INSTRUCTIONS

WARNING: You must operate this fireplace with the fireplace screen in place. Make sure fireplace screen is installed before running fireplace.

NOTICE: During initial operation of new fireplace, burning logs will give off a paper-burning smell. Open window to vent smell. This will only last a few hours.

- STOP! Read the safety information in column

   1.
- 2. Make sure equipment shutoff valve is fully open.
- 3. Set switch in the OFF position.


WARNING: Burner will come on automatically within one minute when the selector switch is in the ON position after the pilot is lit.

## **OPERATION** *Continued*

- 4. Press in and turn control knob clockwise to the OFF position (see Figure 33).
- Wait five (5) minutes to clear out any gas. Then smell for gas, including near the floor. If you smell gas, STOP! Follow "B" in the safety information, column 1. If you don't smell gas, go to the next step.
- Press in and turn control knob counterclockwise to the PILOT position. Press in control knob for five (5) seconds (see Figure 33).

**NOTE**: You may be running this fireplace for the first time after hooking up to gas supply. If so, the control knob may need to be pressed in for 30 seconds or less. This will allow air to bleed from the gas system.

7. With control knob pressed in, press and release igniter button. This will light pilot. The pilot is attached to the front burner. If needed, keep pressing igniter button until pilot lights.



Igniter Button Flame Adjustment Knob *Figure 33 - Control Knob and Igniter Button Location (Shown as Supplied - No Control Options)* 

**NOTE**: If pilot does not stay lit, contact a qualified service person or gas supplier for repairs. Until repairs are made, light pilot with match. To light pilot with match, see <u>Manual Lighting</u> <u>Procedure</u>, **Page 25**.

- 8. Keep control knob pressed in for 30 seconds after lighting pilot. After 30 seconds, release control knob.
  - If control knob does not pop out when released, contact a qualified service person or gas supplier for repairs.

*NOTE:* If pilot goes out, repeat steps 4 through 8, *Page 24*.

- 9. Slightly push in and turn control knob counterclockwise k to the ON position.
- 10. Wait one minute and switch selector switch to the ON position to light burner.
- 11. Set flame adjustment knob to any level between HI and LO.

12. To shut off burners only and keep pilot lit, you can turn control knob clockwise to PILOT position, use remote control manual OFF button, or set selector switch in OFF position.

**CAUTION:** Do not try to adjust heating levels by using the equipment shutoff valve.




Figure 34 - Propane/LP Gas Pilot




Figure 35 - Natural Gas Pilot

3. To shut off burners only and keep pilot lit, you can turn control knob clockwise to PILOT position, use remote control manual OFF button, or set selector switch in OFF position.

#### Shutting Off Burners Only (pilot stays lit)

You may shut off the burners and keep the pilot lit by doing one of the following:

- 1. Turn control knob clockwise to the PILOT position.
- 2. Use remote control manual OFF button.
- 3. Set selector switch in the OFF position.



- Follow steps 1 through 6 under <u>Lighting In-</u> <u>structions</u>, **Page 23**.
- 2. Depress control knob and light pilot with match.
- Keep control knob pressed in for 30 seconds after lighting pilot. After 30 seconds, release control knob. Now follow steps 9 through 11, <u>Lighting Instructions</u>, Page 23.



**NOTE**: All remote control accessories must be purchased separately (see <u>Accessories</u>, **Page 34**). Follow instructions included with the remote control.

# NOTICE: You must light the pilot before using the hand-held remote control unit. See <u>Lighting Instructions</u> on *Page 23*.




Figure 36 - Setting the Selector Switch, Control Knob, and Flame Adjustment Knob for Hand-Held Remote Operation

After lighting, let pilot flame burn for about one minute. Turn control knob to ON position. Adjust flame adjustment knob anywhere between HI and LO. Slide the selector switch to the REMOTE position (see **Figure 36**).

**NOTE**: The burner may light if hand-held remote was on when selector switch was last turned off. You can now turn the burner on and off with the hand-held remote control unit.

*IMPORTANT*: Do not leave selector switch in RE-MOTE or ON position when pilot is not lit. This will drain the battery. Selector Switch in REMOTE Position (Optional Hand-Held Remote Control)

#### GWMT1 WALL MOUNTED THERMOSTAT (OPTIONAL)

Make sure heater switch is on AUTO and set temperature adjustment on wall thermostat to desired setting. Thermostat has been electronically calibrated at the factory and requires no adjustment or leveling.

Upon installation, thermostat must be allowed to stabilize at room temperature for a minimum of 30 minutes for proper operation. See installation instructions on *Page 21* of this manual.



Make sure heater switch is on AUTO. This wall switch works just like the conventional light switch. Flip switch up for on and down for off.

**NOTE**: Make sure that this switch is not in a position to be mistaken for a light switch. This may result in fireplace being inadvertently turned on without proper precautions being taken. See installation instructions on **Page 22** of this manual.

#### OPERATING BLOWER (OPTIONAL)

This blower has three settings: ON, OFF, and AUTO. In ON position, blower will operate constantly. In OFF position, blower will not operate. In AUTO position, blower will start when thermostat senses a sufficient increase in firebox temperature.

**NOTE**: Your fireplace and thermostat blower will not turn on and off at the same time. Fireplace may run for several minutes before blower turns on. After heater modulates to pilot position, blower will continue to run. The blower will shut off after firebox temperature decreases.

## **OPERATION** *Continued*

**NOTE**: It is safe to operate fireplace with blower turned off. However, blower helps distribute heated air from fireplace.




Figure 37 - AUTO/OFF/ON Blower Switch

## **INSPECTING BURNERS**

Check pilot flame pattern and burner flame patterns often.

## **PILOT FLAME PATTERN**

*Figure 38* shows a correct pilot flame pattern. *Figure 39* shows an incorrect pilot flame pattern. The incorrect pilot flame is not touching the thermocouple. This will cause the thermocouple to cool. When the thermocouple cools, the fireplace will shut down.




Figure 39 - Incorrect Pilot Flame Pattern (Propane/LP Shown)

If pilot flame pattern is incorrect, as shown in *Figure 39* 

- turn fireplace off (see <u>To Turn Off Gas to Appli-ance</u>, Page 24)
- see *<u>Troubleshooting</u>*, *Page 29*.

**NOTE**: The pilot flame on natural gas units will have a slight curve, but flame should be blue and have no yellow or orange color.

### **BURNER FLAME PATTERN**


*Figure 40* shows a correct burner flame pattern. *Figure 41* shows an incorrect burner flame pattern. The incorrect burner flame pattern shows sporadic, irregular flame tipping. The flame should not be dark or have an orange/reddish tinge.

**NOTE**: When using the fireplace the first time, the flame will be orange for approximately one hour until the log cures.

If burner flame pattern is incorrect, as shown in *Figure 41* 

- turn fireplace off (see <u>To Turn Off Gas to Appli-ance</u>, Page 24).
- see *Troubleshooting*, *Page 29*.

Bright yellow burner flame; flame will be blue next to burner






Figure 40 - Correct Burner Flame Pattern




Figure 41 - Incorrect Burner Flame Pattern

## **CLEANING AND MAINTENANCE**

WARNING: Turn off appliance and let cool before cleaning.

**CAUTION:** You must keep control areas, burner and circulating air passageways of heater clean. Inspect these areas of heater before each use. Have heater inspected yearly by a qualified service person. Heater may need more frequent cleaning due to excessive lint from carpeting, bedding material, pet hair, etc.

WARNING: Failure to keep the primary air opening(s) of the burner(s) clean may result in sooting and property damage.

Perform a periodic visual check of pilot and burner flame.

## BURNER INJECTOR HOLDER AND PILOT AIR INLET HOLE

The primary air inlet holes allow the proper amount of air to mix with the gas. This provides a clean burning flame. Keep these holes clear of dust, dirt, lint, and pet hair. Clean these air inlet holes prior to each heating season. Blocked air holes will create soot. We recommend that you clean the unit every three months during operation and have fireplace inspected yearly by a qualified service person.

We also recommend that you keep the burner tube and pilot assembly clean and free of dust and dirt. To clean these parts we recommend using compressed air no greater than 30 PSI. Your local computer store, hardware store, or home center may carry compressed air in a can. If using compressed air in a can, please follow the directions on the can. If you don't follow directions on the can, you could damage the pilot assembly.

- 1. Shut off unit, including pilot. Allow unit to cool for at least thirty minutes.
- Inspect burner, pilot, and primary air inlet holes on injector holder for dust and dirt *(see Figure* 42).
- 3. Blow air through ports/slots and holes in burner.

- 4. Check injector holder located at end of burner tube again. Remove any large particles of dust, dirt, lint, or pet hair with a soft cloth or vacuum cleaner nozzle.
- 5. Blow air into primary air holes on injector holder.
- 6. In case any large clumps of dust have now been pushed into burner repeat steps 3 and 4.

Clean pilot assembly also. A yellow tip on pilot flame indicates dust and dirt in pilot assembly. There is a small pilot air inlet hole about 2" from where pilot flame comes out of pilot assembly (see *Figures 43 or 44* depending on model). With unit off, lightly blow air through air inlet hole. You may blow through a drinking straw if compressed air is not available.




Figure 42 - Injector Holder On Outlet Burner Tube





Figure 43 - Pilot Inlet Air Hole (Propane/LP Gas)







#### THE WARRANTY

Innovative Hearth Products ("IHP") 20 Year Limited Warranty warrants your Superior® Brand gas fireplace, Stove or Insert ("Product") to be free from defects in materials and workmanship at the time of manufacture. The product body, firebox and barrier carry the 20 Year Limited Warranty. Ceramic glass carries the 20 Year Limited Warranty against thermal breakage only. After installation, if covered components manufactured by IHP are found to be defective in materials or workmanship during the 20 Year Limited Warranty period and while the Product remains at the site of the original installation, IHP will, at its option, repair or replace the covered components. If repair or replacement is not commercially practical, IHP will, at its option, refund the purchase price or wholesale price of the IHP product, whichever is applicable. IHP will also pay IHP prevailing labor rates, as determined in its sole discretion, incurred in repairing or replacing such components for up to five years. THERE ARE EXCLUSIONS AND LIMITATIONS to this 20 Year Limited Warranty as described herein.

#### **COVERAGE COMMENCEMENT DATE**

Warranty coverage begins on the date of purchase. In the case of new home construction, warranty coverage begins on the date of first occupancy of the dwelling or six months after the sale of the Product by an independent IHP dealer/distributor, whichever occurs earlier. The warranty shall commence no later than 24 months following the date of product shipment from IHP, regardless of the installation or occupancy date.

#### **EXCLUSIONS AND LIMITATIONS**

This 20 Year Limited Warranty applies only if the Product is installed in the United States or Canada and only if operated and maintained in accordance with the printed instructions accompanying the Product and in compliance with all applicable installation and building codes and good trade practices.

This warranty is non-transferable and extends to the original owner only. The Product must be purchased through a listed supplier of IHP and proof of purchase must be provided. The following do not carry the 20 Year Limited Warranty but are warranted as follows:

 Logs – Replacement for one year from the date of installation

 Optional blowers & remote controls – Repair or replacement for one year from the date of installation

 Optional glass doors – Repair or replacement for O0 days from the date of installation

 Tempered glass - Replacement for one year from the date of installation

 Labor coverage – Prevailing IHP labor rates apply for the warranty period of the component

#### Parts not otherwise listed carry a 90 day warranty from the date of installation.

#### Whenever practicable, IHP will provide replacement parts, if available, for a period of 10 years from the last date of manufacture of the Product.

IHP will not be responsible for: (a) damages caused by normal wear and tear, accident, riot, fire, flood or acts of God; (b) damages caused by abuse, negligence, misuse, or unauthorized alteration or repair of the Product affecting its stability or performance (The Product must be subjected to normal use. The Product is designed to burn either natural or propane gas only. Burning conventional fuels such as wood, coal or any other solid fuel will cause damage to the Product, will produce excessive temperatures and could result in a fire hazard.); (c) damages caused by failing to provide proper maintenance and service in accordance with the instructions provided with the Product; (d) damages, repairs or inefficiency resulting from faulty installation or application of the Product.

IHP is not responsible for inadequate fireplace system draft caused by air conditioning and heating systems, mechanical ventilation systems, or general construction conditions which may generate negative pressure in the room in which the appliance is installed. Additionally IHP assumes no responsibility for drafting conditions caused by venting configurations, adjoining trees or buildings, adverse wind conditions or unusual environmental factors and conditions that affect the operation of the unit.

This 20 Year Limited Warranty covers only parts and labor as provided herein. In no case shall IHP be responsible for materials, components or construction, which are not manufactured or supplied by IHP or for the labor necessary to install, repair or remove such materials, components or construction. Additional utility bills incurred due to any malfunction or defect in equipment are not covered by this warranty. All replacement or repair components will be shipped F.O.B. from the nearest stocking IHP factory.

IHP reserves the right to investigate any and all claims against this 20 Year Limited Warranty and to decide, in its sole discretion, upon the method of settlement.
